### AFFIDAVIT OF LESTER BROWN SWORN MAY 22, 2019

I, LESTER BROWN, of the City of Toronto, MAKE OATH AND SAY:

#### Introduction

1. I am a Canadian citizen and a resident of Toronto. Since 1987, I have lived in the same condominium at 39 Parliament Street. The Quayside Project affects me directly. For 20 years, I have been active in local neighborhood associations, development committees, and educational initiatives. As a result, I have personal knowledge of the evidence in this affidavit.

2. I have reviewed the affidavit of Michael Bryant, sworn May 21, 2019. I adopt the definitions Mr. Bryant uses in his affidavit. I share Mr. Bryant's concerns regarding the adverse effects that Quayside Project risks having on privacy.

## **Community Involvement**

- 3. From about 1987 until I retired in 2010, I worked as an auditor at the Canadian Revenue Agency. I am a trained accountant.
- 4. Since retiring, I continue to be involved in several community initiatives. My curriculum vitae detailing my work and volunteer experience is attached as **Exhibit "1"**.
- 5. I have been an active participant in Waterfront Toronto's development projects. I was a member of the development committees for the revitalization of Canada's Sugar Beach and Union Station. I reviewed applications and plans submitted by developers for the proposed redevelopment of each area.
- 6. One of the reasons I volunteer is to ensure that there is public accountability in the urban development process. I believe it is important that major urban developments be subject to grassroots-level input and citizen oversight from all affected communities.

#### **Concerns with the Quayside Project**

- 7. Through my involvement in community groups, and having reviewed the Quayside Agreements, I understand that the Quayside Project as currently proposed will involve the mass collection of personal data from individuals who live in, work, or visit Quayside.
- 8. I am not against the concept of smart city technologies to improve city services. However, based on what I have learned about the Quayside Project, I am left with two significant and troubling concerns. First, that I will not know when, where, how or who exactly is collecting private, personal information. Second, that I will not know or even be able to learn how, by whom or for how long my personal information is being used, once collected.
- 9. I have come to the sincere belief that the Quayside Project as is it currently framed would amount to a substantial intrusion upon my privacy and the privacy of my fellow community members. It would turn Quayside into an area with always-on surveillance, a corner of the City with a digital "Big Brother" always watching which I would find chilling, discomforting and unnerving.
- 10. My volunteer community work has brought me into contact with other Toronto residents who live in or near Quayside who share my concerns about the Quayside Project. My experience in the community leads me to believe that many others do as well.
- During the last year, I have been involved in "Block Sidewalk". This initiative was started by a group of citizens who, like me, are concerned with the Quayside Project and who have become frustrated with the public engagement process.

12. On February 25, 2019, Block Sidewalk launched a campaign, calling for a re-set of the Quayside project. Block Sidewalk's mission and principles are described on its website, <a href="https://www.blocksidewalk.ca">www.blocksidewalk.ca</a>, in this way:

Torontonians should be in charge of deciding our future. These decisions should be made together through fair, democratic, inclusive, transparent and accountable processes. That the public interest isn't and can't be served when decisions are made in secret, in back rooms, behind closed doors, and without public input. That since the day Waterfront Toronto issued the Request For Proposals that ultimately brought us Sidewalk Labs, Torontonians have not led the planning for Quayside and the Port Lands: instead we have been misled. Block Sidewalk is about taking back control of our city and its future. It's about all of us. It's about democracy.

. . .

No one in Toronto asked for a smart neighbourhood or a test-bed. If residents want one, they should use a democratic process to set the rules and make sure policies are in place prior to moving ahead.

Toronto's tech sector is booming, and will continue to do so with or without Sidewalk Labs. Economic development policy and how to manage its impacts on residents is for the city to decide, not Alphabet Inc.

13. I have been advised by Bianca Wylie, one of the founders of the Block Sidewalk campaign, that Block Sidewalk now has approximately 739 members.

#### This Proceeding

14. I have no financial interest in the outcome of this proceeding. My involvement is based only on my concerns about the manner in which the Quayside Project was commenced and is being conducted (I share the concerns about the project expressed by Block Sidewalk in its mission statement, including the absence of a democratic process), the lack of appropriate governance, and for my privacy rights and interests and the privacy rights and interests of my community.
