Since the last report, 8 youth have been moved, including 6 who moved to available spaces at another youth shelter. SSHA continues to work with the service provider to identify solutions for the remaining 3 youth.
	Youth without Shelter	SSHA continues to work with the service provider to transition youth to identified housing. Client moves to housing that were expected to happen this week did not occur. Those moves are anticipated soon, and the remaining beds will be reduced.
