#### AFFIDAVIT OF REBECCA COLEMAN

- I, REBECCA COLEMAN, of the City of Oshawa, in the Regional Municipality of Durham, in the province of Ontario, SWEAR THAT:
- 1. I am the paralegal with the Department of Justice assigned to this matter. As such, I have knowledge of the matters hereinafter deposed to, except where stated to be based on information and belief. As to those matters, I verily believe them to be true.
- 2. As part of my work as a paralegal, I have reviewed a number of media articles, official releases and statements, and Court materials relating to "Freedom Convoy 2022". Official releases and statements and a selection of media articles from a broad spectrum of news sources are provided below in chorological order to assist with background context in these proceedings. This scan is not intended to be exhaustive or representative of the entire collection of media and statements available, but to lay out a chronology of developments reported in the news media and statements made by public officials and various implicated organizations. Court documents from other "Freedom Convoy" court proceedings are provided at the end of my affidavit.
- 3. On November 19, 2021, the Public Health Agency of Canada announced upcoming changes to Canada's border measures in relation to COVID-19. The news release was accessed at: https://www.canada.ca/en/public-

health/news/2021/11/government-of-canada-announces-adjustments-to-canadas-border-measures.html. Attached as **Exhibit A** is a copy of the News Release.

- 4. Canada Unity, one of the organizing groups in what would become the Freedom Convoy 2022, posted a memorandum of understanding (MOU) on their website in mid-December 2021. Based on news reporting it is my understanding that copies of the MOU were sent by registered mail to members of the Government of Canada on or about December 10, 2021.
